Minutes of Worstead Parish Council meeting held at Queen Elizabeth Hall on Tuesday 25th October 2022 at 7.00pm

Present: J. Bacon (Chair), R. Barrett, S. Cole, A. Bond, S. Ginn, K. O'Hara and M. Smith (7.04pm).

For the benefit of the public attending the meeting, all votes taken were by either a show of hands and/or a verbal response from each individual Councillor.

1 Open forum for Public Participation: an opportunity to hear from members of the public No members of the public were present.

Item 2 was postponed until later in the meeting as District/County Councillor was not present.

3 To consider approval of apologies, if applicable.

Apologies were received and approved from M. Annison and J. Carlos-Lawrence (both personal).

4 To approve the minutes of the meeting held on Tuesday 27th September 2022.

The minutes were proposed as a correct record without amendment by Cllr. Barrett and seconded by Cllr. Cole - all Cllrs. AGREED. They were duly signed by the Chair.

Cllr. Cole declared an interest in item 8a PF/22/2250.

All reports were noted.

It was also raised the recent issues about bin collections and damage to properties.

2 District / County Councillor report

District/County Councillor Saul Penfold reported:

- NCC have opened a budget consultation including council tax increase proposed increase but also savings proposals.
- Recycling centre opening times are being reviewed.
- NNDC 'Community Connectors' have been appointed.
- A cost of living summit is being held a summary document will be provided for public following.

It was raised the issues with bin collections in the village and some damage caused to properties. **Action:** Cllr. Cole/Clerk to send information to Cllr. Penfold to raise with NNDC directly.

7 Leisure and Recreation

Cllr. Bacon investigated the possibility of a community shop, however as the PC does not have any property it was AGREED that this would not be a viable project to pursue any further at this time.

Cllr. Cole gave a brief background to the village hall charity, and it has been dentified the area the charity is responsible for includes the village hall car park. Action: Cllrs. Bacon and Cole to meet with village hall Trustees to discuss further.

8 Planning:

PF/22/2250 - Ennor House, Station Road, Worstead, North Walsham, Norfolk, NR28 9RX - Two storey side extension to dwelling

Comment: The PC note the extension is close to the adjoining property boundary. Cllr. Cole abstained from PF/22/2250.

RV/22/2330 - Hall Farm, Sloley Road, Worstead, North Walsham, Norfolk, NR28 9RS - Variation of condition 3 (use and opening hours) of planning permission PF/21/2820 (change of use of agricultural building to equestrian use as an indoor arena in association with Squirrel Wood Equestrian Centre) to allow for additional use and increased hours of use **Comment:** No Objection – however a condition that it is used for dog training and equestrian use only.

RV/22/2331 - The Woodyard, Worstead Park, Sloley Road, Worstead, North Walsham, Norfolk, NR28 9RT - Variation of condition 3 (restricting use and hours of use) of planning permission PF/17/1510 (alterations and conversion of former wood yard barns to wedding venue with associated car parking and landscaping) to allow for the building to be used for other events and alterations to hours of use

Comment: No Objection, providing existing noise restrictions and traffic measures are adhered to.

RV/22/2333 - Hall Farm, Sloley Road, Worstead, North Walsham, Norfolk, NR28 9RS - Variation of condition 5 (Operating times) of planning permission PF/18/1026 to allow use of outdoor arena by other groups, including local dog training groups, and to allow the outdoor arena to be used for alternative hours of operation

Comment: No Objection – however a condition that it is used for dog training and equestrian use only.

9 Highways & Infrastructure:

- a. Dog bins:
 - i. To update and agree dog bin installation in Briggate
 It was AGREED to install an existing dog bin, with fortnightly collections.
 - ii. To consider installation of dog bin Withergate Road

It was AGREED to purchase a new dog bin and install at the end of BR15 on Vicarage Road with fortnightly collections.

Clerk to advise NNDC to seek permission from NCC for installation before proceeding.
