Minutes of Worstead Parish Council meeting held at Queen Elizabeth Hall on Tuesday 16th May 2023 at 7.00pm.

For the benefit of the public all votes taken were by either a show of hands and/or a verbal response from each individual Councillor.

1 Election of Chair

Cllr. John Bacon was nominated as Chairman by Cllr. Barrett; this was seconded by Cllr. Annison. With no further nominations, all AGREED to elect Cllr. Bacon to serve as Chairman for the coming twelve months. Cllr. Bacon signed the Declaration of Acceptance and thanked all Councillors for their support.

2 Election of Vice Chair

Cllr. Bacon invited nominations for the office of Vice-Chairman. Cllr. Barrett was nominated by Cllr. Annison and seconded by Cllr. Gubbins With no further nominations, all agreed to elect Cllr. Barrett to serve as Vice-Chairman for the coming twelve months.

It was AGREED to accept A. Bond's declaration at or before the next meeting, all other declarations had been duly signed

7 To approve the minutes of the meeting held on Tuesday 25th April 2023.

The minutes were proposed as a correct record without amendment by Cllr. R. Barrett and seconded by Cllr. S Gubbins - all Cllrs. present AGREED. They were duly signed by the Chair.

- 9 District / County Councillor report

District/County Councillor Saul Penfold thanked all who voted for their support in being re-elected as District Councillor. The Liberal Democrat's retained the District Council and first AGM being held tomorrow.

At NCC there is change of leadership. A motion is being requested to ask Government for further funding on Highways. A Green motion was put forward, including an apology, for the amount of money spent so far on the Northern Distributor Route, however this was defeated.

There is a consultation open regarding Mayton Woods recycling centre proposed closure – details on NCC website. Closes 26th June 2023.

Cllr. Smith raised an issue on Sandy Hills involving soil being dumped on site and concerns over motorbikes – Cllr. Penfold will investigate this with NNDC.
