Minutes of Worstead Parish Council meeting held at Queen Elizabeth Hall on Tuesday 26th September 2023 at 7.00pm.

1 To consider approval of apologies, if applicable.

Apologies were received and approved from S. Cole (personal).

- 2 Open forum for Public Participation: an opportunity to hear from members of the public A member of the public spoke about a meeting arranged by MP Duncan Baker on Friday 28th September 2023 in North Walsham. It was mentioned some SAM2 devices which record vehicle information; however the Clerk has investigated these, and they are currently not supported in Norfolk. The Chair reported that Speedwatch is the only enforcement available to the PC at this time.
- To receive any declarations of interest in items on the agenda and any requests for dispensation: None.
- 4 To consider election of Vice Chair

Ron Barrett, Vice Chair, has resigned from the PC after many years on the PC - thanks were given for his hard work and support given.

It was AGREED to postpone electing a Vice Chair until the next meeting.

5 To approve the minutes of the meeting held on Tuesday 25th July 2023.

The minutes were proposed as a correct record without amendment by Cllr. A. Abel and seconded by Cllr. J. Gubbins - all Cllrs. present AGREED. They were duly signed by the Chair.

6 District / County Councillor report

District/County Councillor Saul Penfold reported on the District Councils full meeting held last week – the Council supports Blakeney regarding trying to keep the GP surgery open; and aim to help keep sustainable communities; Heritage Action Zone in North Walsham nearly complete; the Cedars (old town hall) to open soon; works still in progress on 'The Lokes'.

County Council – at full meeting a motion was made for costal defence and to lobby the Government for more funding.

A meeting has been arranged with the Highways Engineer to look at resurfacing at the village crossroads and safety issues in this location; also Yarmouth Road and Orpley Lane speed limits and low hanging branches at Westwick crossroads.

The Local Plan is currently with the Planning Inspectorate.

Cllr Penfold attended the Vattenfall presentation, which although does not directly effect Worstead there may be some community funding available to the Parish to apply for.

No further update in the backfilling at Sandy Hills which was reported to NNDC – Cllr. Penfold to follow up and report at next meeting.

Cllr. Penfold left the meeting at 19.28

Cllr Bacon and District Councillor Penfold met with at Briggate resident to understand the land at Briggate issues being raised. The parishioner was advised to seek land registry initially. As this is a civil issue and not PC responsibility it was AGREED no further action from the PC.

Cllr Bacon shared a traffic survey he carried out in the village square for one morning for information only.

This was discussed; however AGREED the PC is not interested and therefore no further action.

It was discussed requesting Highways to review the 2nd phase of the trod path along Honing Road for further improvements as the 2nd section of lowering the verge has not achieved what it was described as doing.
