For the benefit of the public all votes taken were by either a show of hands and/or a verbal response from each individual Councillor.

- 1 **To consider approval of apologies, if applicable.** Apologies were received and approved from Cllr. Annison (personal).
- 2 **Open forum for Public Participation: an opportunity to hear from members of the public** David Adams briefly introduced himself to the Council.
- 3 To receive any declarations of interest in items on the agenda and any requests for dispensation: None.
- 4 **To approve the minutes of the meeting held on Tuesday 28<sup>th</sup> November 2023.** The minutes were proposed as a correct record without amendment by Cllr. Bond and seconded by Cllr. Cole - all Cllrs. present AGREED. They were duly signed by the Chair.

# 5 To consider co-option

Councillors voted unanimously to co-opt David Adams as a Parish Councillor for Worstead. The declaration of office was signed, and David Adams joined the meeting.

# 6 District / County Councillor report

District/County Cllr. Saul Penfold sent apologies to the meeting – no report was received.

## 7 Highways

# a. To receive Highways & Infrastructure report (inc. SAM2 data)

Report shared prior to the meeting. It was noted the SAM2 data recorded high counts of 10mph, however past experience of this indicates this is caused by heavy rainfall. The second SAM2 device to be sent to Westcotec for investigation as not working. Article to go into Woven to seek further volunteers for a community Speedwatch group.

## b. Update on Parish Partnership bid Honing Road trod path.

A bid had been submitted to improve and continue the path along Honing Road, however this scheme was deemed outside the remit of the Parish Partnership as too costly and a 'Capital' project, and removal of large oak tree, therefore it was advised by Highways that the bid would not be successful, however the bid was amended for a 'permissive path' inside the hedge line, which would be supported by Highways, and in line with the PP scheme. This, however, needs the approval of the landowner. To write formally to the Trustees of the Estate to request their support for this project.

- c. To update on Electric Vehicle charging points and agree any actions Awaiting a date for a site survey.
- **d.** To consider parishioner request regarding Briggate hamlet sign Following further update on this proposal, the PC would support this project - subject to full support and funding by the parishioners of Briggate.

**PC Comment:** No Objection for one glamping pod, however concerns for increased vehicular movements and Highways visibility onto Old Yarmouth Road from Sandy Lane should there be any further applications for more glamping pods at this site.
